A. MICHAEL BAINES

CARLOS NELSON COUTINHO

Carlos Nelson Coutinho (1943-2012) was an all-round Marxist intellectual, academic and active political militant, who did much towards innovating the line of the Brazilian Communist Party. As writer and translator he was responsible more than anyone for the diffusion of Gramsci's thought in Brazil. Outside Latin America he is known, among other things, for the translated volume *Gramsci's Political Thought* (Leiden, Brill, 2012). Carlos Nelson was also one of the first members of the Editorial Board of the *IGI*.

Caio Gontijo is a doctoral student in Social Sciences at the University of Buenos Aires (UBA), Master and Bachelor in International Relations at the Pontifical Catholic University of Minas Gerais (PUC Minas). His research interests and recent publications involve contemporary Brazilian politics and Gramscian political theory.

MIGUEL ANGEL MELLINO

Miguel Mellino currently teaches cultural anthropology in the Department of Social and Human Sciences of the Università di Napoli 'L'Orientale', and has taught in various universities in Europe and South America. His varied research experience is seen in review articles and volumes, edited or written by him, in among others, the fields of post-colonialism, new social movements and the politics of identity and belonging, of migration and exclusion.

MASSIMO MODONESI

Current research includes Gramsci's pre-prison writings and the circulation of proletarian culture issues across the Proletcult Institute in Turin and other proletkul't experiences in Europe and Russia. His book-length study *Subalterna/o in Gayatri Spivak* (Ghilarza, ISKRA, 2019) gained first prize in the 2017 *Premio Letterario Antonio Gramsci*.
