## Notes on Contributors / Note sulle autrici e sugli autori

#### Giovanni Mimmo Boninelli

Giovanni Mimmo Boninelli (1951-2016) had a keen interest in Gramsci and was a collaborator of the Ernesto De Martino anthropological Institute. He co-edited the monographic number of the anthropological review "Lares" (2008), entitled *Gramsci ritrovato* and was author of the important volume *Frammenti indigesti: Temi folclorici negli scritti di Antonio Gramsci* (Carocci 2007). As part of his anthropological activities, he was active in workers' struggles, but is perhaps more widely remembered as an ethnomusicologist and for being a performing member of various folk music organizations.

#### Francesco Paolo Colucci

Francesco Paolo Colucci is Emeritus Professor of the University of Milano-Bicocca and has published widely in the field of social psychology. His special interests, stemming among others from Gramsci, Kurt Lewin and John Dewey, include the question of schooling, in which the various aspects of inter-personal and inter-group relationships are a key feature; post-school work experience is likewise an essential topic. Again as regards Gramsci the question of "common sense" plays an important role as a tool of inquiry.

#### Antonio di Meo

Antonio di Meo is a historian of science and culture and in book form has published on the philosophy and history of science, as well as on Gramsci and on Giacomo Leopardi. He is an author and editor of the Istituto della Enciclopedia Italiana's *Storia della scienza* and has coordinated the "History of science in the South of Italy from the Unity of Italy to the present" (Accademia dei XL, 2011). He held the "Seminaires Solvay" of history of science at the invitation of Ilya Prigogine, winner of the Nobel prize for Chemistry. He has taught in various universities and from 1980 to 1996 was Deputy Director of the Fondazione Istituto Gramsci.

#### Giulia La Rocca

Giulia La Rocca graduated from the University of Florence and is presently doing a doctorate based at the Friedrich-Schiller Universität Jena and the University of Padua. Her current research project regards Hegel's conception of the history of philosophy and philosophy in history between tradition and future. Her specific interests include classical German philosophy, especially Kant and Hegel, taking in the autonomy of thought, the dialectic, the philosophy of history and the history of philosophy.

#### Francesco Marola

Francesco Marola teaches and researches on German literature at the University of L'Aquila in Italy. He recently co-edited and contributed to the volume *L'Europa di Gramsci: filosofia, letteratura and traducibilità*, published by Bordeaux editions for the International Gramsci Society-Italy, with a follow-up volume forthcoming. Other publications include the volume *La dialettica dei miti moderni* (Faust-Don Giovanni and Hamlet-Don Quixote) and various articles on German romanticism and preromanticism, with attention paid, among others, to Goethe, Hölderlin and Schlegel.

### Maria Luisa Righi

Luisa Righi works at the Fondazione Gramsci (Rome) and is co-coordinator of the Istituto della Enciclopedia Italiana's *National Edition of Gramsci's Writings*. She has researched thoroughly into political-personal aspects of Gramsci's life and is co-editor of the online *Bibliografia gramsciana*. Apart from her strictly Gramsci-associated work, other fields include trade unions and the role in them of women, as well as the up-to-recently neglected question of the role of women in Gramsci's biography. She has edited volumes (some available on CD-ROM) on the history of the PCI and on Togliatti, essential for understanding the development and history of both.

#### Anita Helena Schlesener

Anita Helena Schlesener is Professor of Political Philosophy and Aesthetics at the Universidade Federal do Paraná; she is currently professor in the Master's and Doctorate in Education at the Universidade Tuiuti do Paraná of Curitiba (Brazil). She gained her Doctorate in History (UFPR) and did post-doctoral work in Education (Universidade Estadual de Campinas). She has written various articles on Gramsci and is editor and co-editor of volumes about his work. In 2022 she assumed her present role as President of the IGS-BR.
